## **INSTRUCTIONS FOR COMPLETION**

Master of Education in Multidisciplinary Leadership students should carefully review the requirements listed in the [calendar](#) and must ensure course selection meets published program requirements. ### **Deadline**

The deadline for submission of this form is posted on the Office of Graduate Programs website.

### **Completion Path**

Students are admitted into the coursework only option. On completion of 12 credit hours and with the approval of the program, students may request to transfer into the project or thesis option.

### **Credit Requirements**

The program requires completion of a minimum of 31 credits. Students may take more credits as required. The total number of credits required to graduate includes the 15 credits of core courses, 3 credits of research methods, required focus area courses, electives and the capstone (comprehensive exam, project or thesis).

### **Focus Area**

Students identify one of three focus areas: Educational Leadership, Assessment and Evaluation **or** Curriculum. Students in the Educational Leadership option must complete 6 credits selected from the range of options outlined in the calendar. Students in the Assessment and Evaluation option must complete EDUC 603 (4 credits). Students in the Curriculum Focus area will work with the program to identify a suitable range of elective credits. Students should ensure coursework that is being applied to meet focus area requirements is indicated by selecting the checkbox beside the course information.

### **Electives**

The number of elective credits will depend on the identified focus area and pathway to degree completion. Students must ensure a suitable number of elective credits are selected to meet the minimum credit requirements (31 credits).
