Project Manager Facilities Management Term, Full-time August 2024 – August 2025

Purpose

Reporting to the Manager of Project Delivery, the Project Manager will support the Facilities Management team in planning, execution, delivery, and evaluation of a range of construction, building, maintenance, and renovation projects within all University campuses. The Project Manager will prepare capital project proposals, monitor project budgets and will participate in decision making with respect to awarding of construction contracts and optimal work scheduling and work crew assignments. The Project Manager will manage several projects at a time while maintaining control over scope, schedule and budget to meet project objectives.

Responsibilities

Specific responsibilities will include but are not limited to the following:

- Project scope definition in collaboration with Facilities Management and other UNBC departments in order to achieve technical, operational and strategic objectives.
- Develop and implement detailed project plans while also effectively dealing with unstructured elements of projects, while aligning project objectives with the University's strategic goals and campus development plans.
- Perform detailed project planning, internal stakeholder engagement, contractor supervision and final project documentation.
- Communicate using a collaborative approach with a high level of tact when engaging with various stakeholder groups.
- Project tracking and reporting, including maintaining accurate and up-to-date project documentation, including schedules, budgets, progress reports, change orders, and closeout documents.
- Generate comprehensive reports for departmental leadership, offering insights into project performance, challenges, and recommended improvements.
- Oversee project construction activities to support quality assurance, safety and communication effectively.

Qualifications

The successful candidate will possess:

- A minimum of 5 years of progressive experience, with a proven track record in project management within University facilities, construction, or related sectors.
- Demonstrated experience managing public sector capital projects.















- Significant experience working with onsite construction and multi-discipline design teams.
- A valid Class 5 BC Driver's License.
- An undergraduate degree preferably in Engineering, Architecture or related field, or
- Technical certification in Building Technology, Construction Management, or a related field

Certification in Project Management (PMP) is considered an asset.

The ideal candidate will also possess the following:

- Demonstrated experience preparing capital project proposals, managing capital projects and strong knowledge of capital project approval processes.
- Experience and abilities for directly managing consultants, contractors and suppliers.
- Proficiency in MS Excel, MS Project software and budgeting experience, particularly in the public sector.
- Extensive knowledge of project management methodologies, tools, and software.
- Proven and highly effective communication skills.
- Exceptional leadership, and interpersonal, skills. Strong analytical and problem-solving aptitude.
- Demonstrated ability to manage multiple projects concurrently while maintaining exceptional attention to detail.
- Familiarity with building codes, regulations, and sustainability practices.
- Proficiency in budgeting, cost estimation, and financial management.

An equivalent combination of education and experience will be considered.

Salary

The starting salary will be determined with consideration of the successful candidate's relevant education, skills and experience, as well as alignment with the University's compensation policy. The salary range for this position is expected to be \$78,000 - \$86,000
