REFUND POLICY: In the event that Continuing Studies cancels a Wildlife Dangerous Tree course due to low enrolment or other unforeseen circumstances, all registrants will automatically be issued a full refund in the manner of original payment, or by cheque if payment was made by cash or debit. If you withdraw from a course, you are required to notify Continuing Studies by telephone, email, fax or letter. Voice mail is not considered an adequate method of notification. Notification MUST be received up to and including 11 days prior to the course start date to qualify for a full refund, no financial penalty. For withdrawals after this time, 10 days prior to the course start date, a 100% financial penalty applies; a refund will NOT be issued.



## Upon registration, participants must have the following prerequisites:

Three or more years of practical field experience in the area of forestry, resource management, parks management, wildland fire protection, arboriculture, geophysical exploration or a related field; and,

Grade 10 equivalency in reading, writing and arithmetic skills (including the ability to calculate percentages); and,

Ability to identify tree species native to BC; and,

Proven forestry measurement skills to determine tree diameter, height, lean, stem cross-section, and skill in distance measuring.

In addition to the above, for attending the Fire Module:

Persons must demonstrate that they have recent fire-line experience (at least 10 days over previous three years; OR

Persons must have a minimum five days of documented Dangerous Tree assessment experience (harvesting/silviculture, parks) in the previous calendar year.

**Please note:** You are required to check each course prerequisite that you meet, and then sign and date. This is your personal declaration that you meet the course prerequisites for this course. A false declaration or misrepresentation is fraudulent. Should you not meet the necessary course prerequisites, you will be denied certification.

Under the terms of our agreement with the WDTC, Continuing Studies provides a list of current assessors upon request with the WDTC. Under the terms of this agreement UNBC also provides a list of current Fire assessors to BC Wildfire Services (BCWS), twice a year to support certificate verification. Personal information on this form will be shared confidentially with members of the WDTC. Certificate status may be confirmed upon request by contractors and employers for the purpose of confirming qualifications.

You have the right to revoke consent to the collection, use, retention, and disclosure of personal information at any time, but doing so will result in consequences including, but not limited to, forfeiting registration in the course.

## How we will protect your information:

UNBC is obligated to protect your personal information and has various processes in place to ensure it is secure.

## How long we will keep your information:

The Freedom of Information and Protection of Privacy Act allows us to keep your Personal Information for at least one year after collection and when its period of usefulness is over we will securely delete or destroy it.
