G. Inspection Updates

g.1) Building Inspection Updates – Scott

Building inspection planned for March 25th at 2:00pm and looking at building 3. There are a couple scheduled for April. If anyone would like to join on March 25th, please free to come along. Sign up for upcoming inspections as well.

g.2) Lab Inspection Report – Jordan

Broken mercury thermometer in a lab in building 9. It was in an incubator, and they do not know who broke it. The supervisor assumes that a student went into the incubator and knocked the thermometer out and it broke on the ground. They could not find the actual bulb of the thermometer. No student confessed on who broke it. The spill was cleaned up, but the bulb was never found. Jordan collected the remaining mercury thermometers and is working on getting the remaining mercury thermometers off campus.

Scott: working on gathering the remaining mercury out of the labs and the mercury thermometers will be replaced by alcohol thermometers. The alcohol thermometer technology has come along way and can be used in place of the mercury thermometers.

Scott: passed our radiation exam. The license has been renewed for 3 years. Jordan will be taking the radiation course in April and once that is done, he will be the new radiation officer.

H. New Business

h.1) Faculty input/questions: Tina

Met with faculty of Humanities and the faculty of Indigenous and one question came forward: in terms of the installing of the cameras, one of the faculty members was asking if the cameras will be facing the parking lot. Tina let them know that she doesn't think that cameras will be posted everywhere. Tina also let them know if they are going to UNBC to work after hours, to check in with Security and let them know that they are there so Security is aware.

Scott: Looking to change the working alone process. We need to look at the numbers of people who use the working alone.

The cameras will not be aimed at the parking lot. It is going to be focused on the main doors and the main corridors. The camera scope can change in time, but it is focused on the real main points.

Saphida: With the working alone, do you consult with the grad student's association as they generally work alone in the labs.

Scott: How often/many students would be working alone in a month?

Saphida: a large percentage work alone on the weekends/evenings

Alencia: She has run into a few students; she had reminded them to contact security to let them know as well. Most students do tell their supervisor, but security needs to be notified as well

Scott: Do the supervisors or any faculty members know when the students are working on the weekend? If they needed to, they could also contact security.

Saphida: Their supervisors should know when they are working.

Scott: Is there a way to connect with the grad students?

Saphida: The faculty or the Graduation Student Association, you can communicate through that avenue.

Maik: the working alone procedure is tied in with the safety training.

Scott: Maybe a grad student orientation process for labs and other classroom space.

Saphida: When Jordan does train, is it possible to ensure that students have logged onto the safety app?

Jordan: It can be added in, and he has added the QR codes to the subscribe to the labs list.

Is there a message that can be to program chairs that can be forwarded to faculty to let them know what the process is for graduate students working alone.

Scott: There is a process, but it seems like we need to communicate it wider.
